UPDATES/CHANGES

(1) NATIONAL BACKGROUND REPORT

- a. Effective February 1, 2018 The SCDMV no longer accepts SLED Reports for any type of license of application.
- b. Conditions to submit a National Criminal History Report
 - i. Each dealer is require to submit a National Criminal History Report under the following conditions:
 - 1. First-time applicant
 - 2. Renewing a dealer's license
 - 3. Adding an owner
- c. The required Applya National Background Report can be found on our website (www.scdmyonline.com) and obtained three different ways:
 - i. Typing in "the national criminal search" in the search box on the home page

(2) **IMF**

- a. Every dealer must collect the IMF.
- b. When a customer purchases a vehicle from a dealer and chooses to title and/or register the vehicle at the DMV, the IMF will be due at the time of the title and/or registration transaction.
